Norman Insurance Trophy for highest boys score over all age groups (recurve)
Norman Insurance Team Trophy to comprise 4 highest scores form one club (recurve)
Best Gold and Colour Prizes.

Parent and Guardian awards subject to entry.

Winners will be asked to sign for trophies and ensure their safe return.

Medals will be awarded as follows

A gold medal if between one and three shoot the same round.

A gold and silver if four or five shoot the same round.

Gold, Silver and Bronze medals if six or more shoot the same round.
